(ART. 13 EU REG. 2016/679)**

Dear user,

a) Data Controller

b) Purpose of the processing

c) Processing and storage methods

We point out that, in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to art. 5 of the G.D.P.R. 2016/679, subject to your free and explicit consent expressed in the annex to this information, your personal data will be kept for the period of time necessary to achieve the purposes for which they are collected and processed and anyway no later than the established terms. by tax laws, labor and social security regulations and by the relevant civil code and for a further ten years.

d) Scope of communication and dissemination

We also inform you that the data collected will never be disclosed and will not be communicated without your explicit consent, except for the necessary communications that may involve the transfer of data to public bodies, consultants or other subjects for compliance. of legal obligations. Furthermore, such data may be known, within the limits of current legislation, by employees and / or collaborators expressly appointed and appointed by the Data Controller.

e) Special categories of personal data

f) Rights of the interested party

- Cancellation (Article 17 of EU Regulation no. 2016/679);

- Portability, understood as the right to obtain from the data controller the data in a structured format of common use and readable by an automatic device to transmit them to another data controller without impediments (Article 20 of EU Regulation no. 2016/679);
- Opposition to processing (Article 21 EU Regulation no. 2016/679);
- Revocation of the consent to the processing, without prejudice to the lawfulness of the processing based on the consent acquired before the revocation (Article 7, paragraph 3 of EU Regulation no. 2016/679);
- Propose a complaint to the Guarantor Authority for the Protection of Personal Data (Article 51 of EU Regulation no. 2016/679).
